	Review of actions	
	More than 60 laptops have been given out, with another 30 on order. Some children had been trying to access their learning on a phone.	
	Governor challenge: Can school afford these? We are using some of the underspend on the purchase of laptops, and there is speculation that more are to be made available by the government.	
	Governor challenge: Do the laptops come with instructions on what they can be used for? They have software installed and appropriate restrictions enabled.	
	Governors thanked the headteacher for the school's efforts to enable access to laptops for children.

	Governors ratified the finance policy	
GB/07/21	Headteacher's report	
	The headteacher had circulated her report in advance for governors to read and to prepare questions. She spoke to the report, highlighting some items to governors.	
	The following items were discussed by governors.	
	Free School Meals (FSM)	
	The FSM numbers at the school have doubled in the last year, probably as a result of the current economic climate.	
	Governor challenge: How are you coping with the FSM situation? Food hampers have been distributed, but only about 40% of the hampers have been picked up. Vouchers are being issued from this week in place of the hampers and have far greater take up.	
	Governor challenge: What happens with the spare hampers that are not picked up? They go back into the catering budget and the funding can be accessed in future.	
	Governor challenge: How does the quality compare to the ones seen on the news recently? They are similar to what has been seen on the news. They are for one child for five lunches. The LA now includes a card with recipe ideas to use the hampers fully.	
	Looked After Children	
	Governor challenge: There seems to suddenly be a lot of LAC children, is there a reason? No particular reason, they are from three different families.	
	Covid response	
	Take up requests for key worker places in school have been above national levels. A lot of support from the local authority has been forthcoming. Several bubbles have been closed in school due to contact with an infected person.	
	Governor challenge: Are you sure it is okay for a bubble to reopen tomorrow? Yes, the isolation period is over, although many parents are not sending children back in as they have now made alternative childcare arrangements.	
	A governor said that she was impressed that staff have got to grips with using Teams so quickly and are using this resource effectively.	
	The chair offered condolences to those staff who are off ill with Covid and wished them a speedy recovery.	
	School Development Plan (SIP)	
	The headteacher gave an update on progress made on the SIP priorities, which have continued despite current circumstances.	
	Governor challenge: How are the reception class coping with the circumstances?	

		ACTION
	They seem to be okay, they seem to be more settled being dropped off at the gate than with parents bringing them into school. It is contributing to their independence. Some children in school are suffering from anxiety and support is being provided.	
	The chair was pleased to note the support from the local authority to the school in the circumstances and offered his thanks for this.	
	The chair commented on the Reading for Pleasure project, saying that he was impressed with the work taking place and has recommended it to the local secondary school as a useful approach at that age range. He thanked the staff for their work on this.	
	Governor challenge: Have staff noted a difference in reading? A difference was being observed prior to lockdown, which has disrupted the learning. The phonics teaching has made a huge difference to the approach to reading and the outcomes across the school.	
	The headteacher was thanked for her comprehensive report.

	Mrs Smith is to arrange to undertake the safeguarding checklist with school staff via zoom and send it to the local authority within the next week.	JS

	School budget	
	This was discussed at the business committee. Currently forecasting an £80k surplus which will be further reduced due to laptop purchase. Remains a healthy budget.

	The clerk spoke to the three Director's Reports, on Blended Learning, Considering Everyone's Wellbeing in School, and Children Missing Education, highlighting the actions for governors.	
	Blended Learning	
	Governor challenge: Do we have a blended learning plan? Yes, we are currently following the blended learning plan, which has been adapted as things progress. All teachers are asked to provide 3 to 4 hours of learning a day, and two one hour slots for live teaching, although they don't use the full hour. There are interventions taking place as well. The school's policy was approved at the last meeting. Children do receive verbal or written feedback on their work from teachers.	
	A governor said that the bended learning has been fantastic, and it was impressive how school have turned this all around in 24 hours. Governors agreed that the school should be really proud of that achievement.	
	Wellbeing	
	Mrs Smith reported that she has attended a webinar on wellbeing, which was very good.	
	Governor challenge: Are there any wellbeing issues in school? Some people have been dramatically affected at times, and people have struggled as a result of the changes in school and the added impact of not having much of a break. School have tried to make adjustments where possible to ease the workload. Staff have tried really hard and found criticism from parents difficult at times, but all are embracing the changes.	
	Governor challenge: Have any whole-staff zoom meetings taken place? There have been a few.	
	It was agreed that the Children Missing Education report be discussed at the Strategic Development Committee.	SDC Cmttee

	From chair	
	The chair informed governors that a complaint had been received and had been handled appropriately.	
	The chair said that social media comments made about the school and staff from people in the wider community were a very real concern, as they included threats of physical violence towards staff. He has sought appropriate advice from legal services at the local authority. He has also raised concerns with two local MP's. The incident has been reported to the Police who has offered victim support and have taken the incident very seriously indeed.
